In the reference 1st cited, the University has granted the Provisional Affiliation order to College of Pharmacy, Sri Ramakrishna Institute of Paramedical Sciences, 395, Sarojini Naidu Road, Coimbatore - 641 044, for conducting the Pharm.D degree course with an annual intake of 30 seats and Pharm.D (Post Baccalaureate) degree course with an annual intake of 10 seats from the Academic Year 2008-2009.
- 2. In the reference 2nd cited, Grant of Continuance of Provisional Affiliation had been issued to conduct Pharm.D and Pharm.D(Post Baccalaureate) Degree Courses, for the academic year 2019-2020 to the said institution.
- 3. In the reference 3rd cited, the Pharmacy Council of India, New Delhi (PCI) has granted approval for 30 seats for the academic year 2020-2021 to conduct Pharm.D degree course and approval for 10 seats for the academic year 2020-2021 to conduct Pharm.D (Post Baccalaureate) degree course College of Pharmacy, Sri Ramakrishna Institute of Paramedical Sciences. Coimbatore.

- 4. Due to Covid-19 pandemic, the University inspection for the Academic year 2020-2021 could not be conducted. In the Resolution No. 4(1) passed at the 277th Governing Council meeting held on 30.09.2020, it was resolved to grant CPA/CCPA without conducting inspection for the Academic year 2020-2021 to the Pharmacy Institutions after getting undertakings for the Academic year 2020-2021 alone as a one time measure due to COVID-19. Accordingly, the Institution was informed vide this University communication 6th cited, to furnish undertakings, in this regard.
- 5. In the reference 7th cited, the Managing Trustee of the said Institution has submitted a notarized affidavit duly signed to abide by the appropriate rules regarding non conduct of regular Inspection for the Academic year 2020-2021 for issue of CPA, as resolved in the Governing Council resolution communicated.
- 6. In the pursuance of the above, the University grants Continuance of Provisional Affiliation to College of Pharmacy, Sri Ramakrishna Institute of Paramedical Sciences, 395, Sarojini Naidu Road, Coimbatore 641 044 for conducting Pharm.D and Pharm.D ((Post Baccalaureate) Degree Courses for the academic year 2020-2021 as indicated below subject to the usual conditions already intimated in the Provisional Affiliation orders of this University.
